VAT number 918561701.

1. Terms

- 1.1 When you purchase product/s from the [greatprints.co.uk] you agree to be bound by these terms and conditions.
- 1.2 The terms and conditions do not affect your statutory rights as a consumer.
- 1.3 Bauer may change these terms and conditions at any time. Any such changes will take effect when posted on the website and it is your responsibility to read these terms and conditions on each occasion you use this website.
- 1.4 If you do not accept these Terms, do not use this website.

2. Your Status

- 2.1 By placing an order through our website you warrant that: you are legally capable of entering into binding contracts; you are at least 18 years old;
- 2.2 you understand and agree to comply with these Terms.

3. Our Status

- 3.1 The products are provided for sale by us and, provided your order is accepted, the contract for the product will be between you and us and this will be formed when we send you a confirmation.

5. Prices and Payments

- 5.1 The price of any products will be as quoted on the website, except in cases of obvious error.
- 5.2 Prices include VAT and delivery costs to the UK (where applicable)
- 5.3 Despite our best efforts, some of the products listed on our website may be incorrectly priced. Where a product or service correct price is less than our stated price, we will charge the lower amount, if a product or service correct price is higher than the price stated on our website, we contact your for instruction or reject your order and notify you of such rejection. Bauer is under no obligation to provide the product to you at the incorrect (lower) price, even if you have received an Order Confirmation, if the pricing error is obvious and unmistakable and could have reasonably been recognised as mispricing.
- 5.4 All prices quoted are in pounds sterling.

6. Refunds and cancellations

- 6.1 You may cancel the order at any time but no later than 30 days after the day you

received the product by:

- sending notice of cancellation by email ensuring that you quote your name, address and order reference number to greatprints@bauermedia.co.uk;

6.2 If you cancel an order, you are responsible for arranging and paying for the return.

7. Damaged, Defective, Incorrectly Sent, Incorrectly Advertised Items

7.1 If you receive goods which were not what you ordered or which are damaged or defective, or are of a different quantity to that stated on your order form, Bauer shall be responsible for any shortage or non-delivery, replace or repair any damaged or defective goods, or refund to you the amount you paid for the goods in question. 10. Import Duty
